



## Rules & Procedures

*Kindergarten LES P'TITS TRAPPEURS will open from Sunday to Friday from 8:45AM until 4:45PM, on a full day or a half day basis (with or without meal) for children from 3 years old to 11 years old. Capacity is 24 children.*

### **Article 1. Condition of admission of collective reception of a minor**

Admission of a minor is subject to receipt of the following documents:

- Mandatory vaccinations certificate or proof of exemption.
- Health sheet (to be completed by the parent/guardian and provided on the first day)

**The child's parent or guardian will have to fulfil these obligations in order for the child to be accepted**

### **Minor medical treatment CASF (Law 20 February 2003)**

Prescription medicine cannot be given to a minor without the prescription itself. In the event that a minor is under prescriptive treatment, their parent or legal guardian must provide the prescription as well as the medicine with the name of the child on it. The Director will decide the best way to proceed.

### **Article 2. Registration**

During registration, we ask that:

- You provide a copy of the vaccination page of the "child's health record", or proof of medical exemption in the case of non-vaccination.
- You complete the mandatory « Health sheet »
- If a member of the family or friend is going to collect your child, you provide their name(s) on the Registration Sheet. ID will be required when collecting your child.
- Children must be « potty trained ».
- We do not accept sick children (see General Terms and Conditions of les P'tits Trappeurs)

### **Article 3. Arrival & Departure**

The drop off and collection of children will be done by a single legal guardian and under their own responsibility.

### **Parents must bring appropriate clothing for activities and weather conditions:**

- Ski Suit
  - Fleece jacket/ warm hat/ sunglasses, sun block/ gloves
  - Spare clothes: underpants, pants, & socks
  - Due to high UV levels in the mountains, please bring appropriate sun cream.
- Club staff will endeavour to take care of personal effects but cannot be responsible for the loss or damage to any such items.

### **Article 4. Meals & snacks**

In accordance with the hazard awareness regulations and for hygiene reasons, meals and snack are to be supplied only by the kindergarten and must be consumed on site.

- It is imperative that session times are respected in terms of lunchtime departure and arrival times
- If a child is withdrawn from the kids club without notification to the Director, meals will still be chargeable





#### **Article 5. Activities planning**

- The suggested activities on the board or in the brochure will be subject to weather conditions, the availability of staff and the number of participants.
- In order to ensure that the Club runs as smoothly and efficiently as possible, as well as the well being of your child, it is recommended that parents/guardians do not take part in Club activities.
- Personal toys are not permitted.
- For safety reasons, a helmet is required for sledging time.

#### **Ski School (excludes ESF Day-care packages)**

Please inform us if:

- Your child has group ski lessons, and if you would like us to collect them. Please inform us in advance.
- Your child has a ski pass.
- Your child has a ski lesson between noon and 2 PM (in such cases your child should have lunch prior to entering the kids club)
- You collect your child prior to the end of their ski lesson (please inform us as soon as possible)
